Hampton Roads Regional Benchmarking Study 2024 Released

The Hampton Roads Regional Benchmarking Study evaluates the performance of the region in comparison to 19 similarly sized Metropolitan Statistical Areas (MSAs). It highlights key metrics and statistics that offer insight into Hampton Roads' economic competitiveness and provides information to support decision-making related to quality of life. The study includes a variety of graphs and illustrations to help understand the region's well-being, both in comparison to other areas and through the lens of changing regional trends.

The 2024 Benchmarking Study is divided into 12 sections that assess the region's performance across various areas ranging from the economy, defense, equity, education, and government finances. The final section includes metrics comparing the planning region's localities to one another.




